

MUTUAL/ AUTOMATIC AID AGREEMENT  
JACKSON/ JOSEPHINE COUNTY

AMENDMENT - April 21<sup>st</sup>, 1998

The parties to this agreement recognize the existence of the above titled agreement executed on July 1<sup>st</sup>, 1992 and continue to honor this agreement in its original form. The parties also recognize the ability for this agreement to be amended for the purpose of adding agencies with a recommendation of the Rogue Valley Fire Chief's Association and as approved by the Chief Executive Officer of each of the existing parties. (paragraph 10)

Therefore, it is recommended at this time to add Wolf Creek Rural Fire Protection District as a party to this agreement. It is also recommended at this time to remove the City of Central Point and the City of Gold Hill as a party to this agreement. This agreement will stand until the whole agreement is updated in the future. The original amendment shall be on file at Jackson County Fire District #3.
