

**ROGUE VALLEY FIRE CHIEFS ASSOCIATION
MUTUAL / AUTOMATIC AID AGREEMENT
JACKSON / JOSEPHINE COUNTIES
Amendment April 20, 2010**

The parties to this agreement recognize the existence of the Rogue Valley Fire Chiefs Association Mutual/Automatic Aid Agreement executed on July 1st, 1992 and continue to honor this agreement in its original form. The parties also recognize the ability for this agreement to be amended for the purpose of adding agencies with a recommendation of the Rogue Valley Fire Chiefs Association and as approved by the Chief Executive Officer of each existing parties. (Paragraph 10)

Therefore, it is recommended at this time to add Greensprings Rural Fire District as a party to this agreement. It is also recommended at this time to remove the Central Point Fire Department, Gold Hill fire Department, Phoenix Fire Department, Talent Fire Department, Eagle Point Fire Department, and the Veterans Administration as a party to this agreement. This agreement will stand until the whole agreement is updated in the future. The original amendment shall be on file at Jackson County Fire District #3.

COUNTERPARTS. This Amendment may be executed in any number of counterparts, each of which, when executed and delivered (including delivery by facsimile), shall be deemed and original, and all of which counterparts of this contract, taken together will be deemed to be but one and the same.
